## Rules for prevention of Ragging

Ragging is a non-bailable offence under the criminal penal code. The Government and University have issued orders to punish the offenders even by dismissal from the college. The Honourable High Court and Supreme Court have issued directives meant for educational institutions to take steps for prevention of the illegal acts known by the name of ragging and emphasized the need to take speedy action for giving stringent punishments to those who disobey the rules on ragging.

It is necessary that students must observe decency and decorum in their behaviour with fellow students and especially so in their behaviour towards junior students of first year. *Strict disciplinary action including summary dismissal from the college will be initiated against students who get involved in ragging related criminal acts. Such cases will be handed over to the police department, on the spot.*

Indecent or vulgar talk, coercive and intimidating tactics leading to the humiliation of individuals, physical assaults or tussles in any manner, compulsion to make a student do things against the freewill of the student, collection of money illegally and all those direct or indirect involvement in acts that will be termed abnormal and are against the basic principles of personal dignity, human rights and liberty will be considered as ragging and any student getting involved in such uncivilized acts either inside the campus or outside will be punished.

An anti-ragging committee has been authorized to report to the principal the names of students who are seen to have resorted to the

criminal acts of ragging.

Any complaint of ragging has to be reported to the members of the Committee, who in turn will inform the same to the Principal. The committee members shall focus attention for eradication of the menace of the antisocial, criminal and offensive actions of ragging. The members also shall work for bringing awareness among all for maintaining true cordiality in interpersonal behaviour.

The Anti-Ragging Squad members shall conduct periodical rounds through all areas of the campus and college to ensure that no offensive actions of ragging are taking place. The Squad members shall not allow the students to assemble in and around the bath rooms during intervals.

Students are warned not to get involved in any form of ragging. It should be the earnest effort of students to spread the message of fraternity, love and mutual respect.

All students are expected to take an Anti Ragging pledge


